Other requirements

- Successful completion of all pre-professional course work with a 3.0 cumulative QPA at Duquesne University and a "C" or better in all
 courses.
- 2. A 3.0 cumulative GPA in the pre-requisite math and science courses by the end of the pre-professional phase.
- 3. Documentation of current Basic Life Support.
- 4. Completion of a physical examination and other pre-clinical health requirements, including record of immunizations.
- 5. Completion of 16 hours of shadowing or paid experience with a registered/licensed OTR at a minimum of two separate practice settings.
- 6. Students who se first language is not English must meet published language proficiency requirement for entry into graduate programs.
- 7. Departmental approval.

Graduates of this program will be eligible to sit for the national certification examination for the occupational therapist administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be an Occupational Therapist, Registered (OTR). In addition, most states require licensure in order to practice, however, most states are usually based on the results of the NBCOT Certification Examination. A felony conviction may affect a graduate's ability to sit for the NBCOT Certification Examination or attain state licensure.
