

# 2025-2026 V5 Verification Worksheet

Your 2025-2026 Free Application for Federal Student Aid (FAFSA) was selected for a review process called verification. To verify that you provided correct information on your FAFSA, Duquesne University will compare your FAFSA information to this worksheet and with any other required documentation. If there are differences, your FAFSA information may require correction which may result in a re-calculation of federal aid.

Verification must be completed and processed to meet disbursement eligibility for some financial aid programs. This form, 2023 Tax Information, and other required documentation must be submitted to the Duquesne University Financial Aid Office at your earliest convenience.
