#### **CRIMINAL PROSECUTION PROGRAM**

The Criminal Prosecution Program is a must for anyone interested in litigation or public interest. It is a way to 'learn by doing.' This Clinic entails a rotational program at the Allegheny County District Attorney's Office, which means that each student gets to work for about a month in each Division from Appeals to Violent Crimes and Firearms, General Trial and more.

Each week, our clinic meets with Judge David Spurgeon and Deputy District Attorney Jennifer DiGiovanni in court to review our weekly assignments, trials, and receives an advanced criminal procedure lesson from Judge Spurgeon and Prof. DiGiovanni. I am grateful for the practical experience in litigation.

#### FAMILY LAW CLINIC

The Thomas R. Kline School of Law of Duquesne University's Family Law Clinic has partnered with the University of Pittsburgh School of Law to launch a hotline for low-income clients to receive limited legal services for free. This hotline assures that those with family law questions are in contact with a student-attorney within 2 business days.

**Professor Wesley Oliver** and **Associate Professor Kate Norton** of the Thomas R. # **PA INNOCENCE PROJECT**



Join us in welcoming James "Jim" Kelly home. Jim walked free from Pennsylvania State Correctional Institution at Somerset after Judge Bronson Glenn granted the Commonwealth's motion to dismiss all charges, resulting in his release and exoneration. Jim is headed back to Philadelphia after spending nearly three decades incarcerated for a 1993 crime that he did not commit. Jim, a proud father and veteran, is excited to return home and bask in a new normal surrounded by his grandchildren.

Jim's innocence claim was backed by many over the years, including his former cellmate, George Bussinger, who raised money to help Jim obtain legal assistance. George's efforts led to former Chester County Court of Common Pleas President Judge Lawrence Wood joining Jim's quest for freedom.

Jim is welcomed home by his family and legal team at the Project including our Managing Attorney Liz DeLosa, who led our team, supported by Nilam Sanghvi. Many thanks to other Project staff members who worked on this case over the years, including Charlotte Whitmore, Shaina Tyler, Zach Stern, Ryan Becker, Haley Filippine, and Anjali Nahata.

# **RE-ENTRY LEGAL SERVICES CLINIC**

Last semester the students at the Re-Entry Legal Services Clinic counseled over 30 prospective clients in the best strategy to clear their records. Most of the clients are underemployed because of their records. Most of our clients had been arrest free at least 10 years, routinely volunteer in their communities, and brought recommendation letters. We are excited to have a group we can immediately assist.

This year, the students in the re-entry clinic completed three pardon applications and two expungements for clients who have been unable to gain employment due to their criminal history. Additionally, the students have advised several clients on their timeline for sealing their criminal history, currently aiding 24 clients with re-entry services, all of whom have reformed themselves from their past mistakes and are eager to make a positive imprint in their communities.

#### **ELDER JUSTICE CONSORTIUM**

On November 19, 2024, Professors Grace Orsatti and Kate Norton represented the Thomas R. Kline School of Law, Tribone Center for Clinical Legal Education by attending the PA Supreme Court meeting with the Elder Justice Consortium in Harrisburg, PA. They presented a slideshow on the current work of the Elder Justice Consortium across the state to the judges.

On Saturday, September 7 the Wills and Healthcare Decisions Clinic had a table at the Lawrenceville "Housing for All" Resource Fair from 12:30pm-3:30pm. This fair was sponsored by the Lawrenceville United & State Rep. Lindsay Powell and assisted members of the community, including seniors. regarding rental housing to homeownership, community land trusts available, tenant rights workshop, access to rent assistance, knowing the worth of their home and avoiding predatory practices against homeowners, home repair programs and accessibility modifications, financing programs for homeowners, and protections from property reassessments. There were 15+ housing and elderly related organizations at this tabling event, including the Wills and Healthcare Decisions Clinic of Duquesne Kline.
